Graduate students who have completed the minimum period of study, fulfilled all required courses and credits, and prepared the outline and basic content of their degree dissertations may apply for a doctoral degree candidate qualification examination. The students are deemed to have passed the examination if at least two-thirds of the examination committee members agree so.	Students who fail their qualification examinations may not apply for dissertation defense. Those who fail the qualification examinations twice will be dismissed.
